- Academic/ Technical Qualification Certificates/Marks Sheets which will also include whether Diploma is approved for employment in J&K and whether the said Institution is authorised to award such Diploma.
- 2. Date of Birth Certificate/Matriculation Certificate.
- 3. Age and Health Certificate issued by Chief Medical Officer.
- 4. Permanent Resident Certificate/State Subject issued by the Competent Authority.
- 5. Character and Antecedents Certificate.
- Certificate from concerned Deputy Director, Employment and to the effect that no loan under self-employment scheme has been taken by the appointee.
- 7. Relevant category certificates.
- 8. Any other relevant certificate as required in the rules.

The appointment of the above candidates as Junior Assistants in this department shall further be subject to the following conditions:-

- Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her Character and Antecedents is received from Office of the IGP, CID,J&K, to whom a reference shall be made by the concerned Drawing & Disbursing Officer, the candidate shall have no right to claim his/her appointment as Junior Assistant and his/her appointment as such, shall be deemed to have been cancelled ab-initio;
- Verification/genuineness of the Qualification Certificates, Reserved Category Certificates from the concerned issuing authorities.

The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (i) and (ii) above is received in their favour.

The appointees shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24-12-2009.

The inter se- seniority of the appointees shall be in accordance with the merit secured by these appointees as per the selection list furnished by the J&K Service Selection Board.
