The appointees shall be on probation for a period of two years and shall be allowed to join only on production of the following certificates/documents in original:-

1. Educational qualification/Technical qualification like degree/diploma issued by a recognized institute/university valid for employment in J&K.
2. Date of Birth certificate (Secondary School Examination certificate)/Matriculation Certificate.
3. Permanent resident certificate /State subject.
4. Health certificate issued by an officer of the State Health Department not below the rank of Chief Medical Officer.
5. Character and antecedents certificates issued by competent authority/State CID Department.
6. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained /availed by the concerned candidates.
7. Reserved category certificate issued by the competent authority, wherever required.
8. Any other relevant certificate as required under rules.

Further, the above appointments are provisional and subject to the following conditions:-

1. The Executive Engineers shall personally verify the genuineness of qualification certificates/Category Certificates/Permanent Resident Certificate etc. Under rules.
2. Each appointee shall give an undertaking in the shape of an affidavit that in case any adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, J&K to whom reference shall be made by the authority to whom they shall submit their joining report or any other adverse report about their qualification, the candidate shall have no right to claim his/her appointment as Junior Engineer (Civil) and his/her appointment as such shall be deemed to be void-ab-initio and cancelled as such.
