



**Subject:-** Suspension of DEE class Civil and Sanitary Card with registration No: SE/Hyd/Sgr/DEE-152/Civil and Sanitary of 2001-02 in the name of Bhat Sanitation Prop: Naseer Ahmad Bhat S/o: Gh. Rasool Bhat R/o: Brain, Nishat, Srinagar bearing endorsement No: 6292-93 dated: 23-11-2001 claimed to have been issued by Superintending Engineer, Hydraulic Circle, Srinagar.

## Order

1. Whereas Chief Engineer R&B Department vide his letter No: CE/RBK/WS/29538-40 dated: 19-02-2021 desired to clarify the position in respect of DEE class Civil and Sanitary card in the name of Bhat Sanitation issued under endorsement No: 6292-93 dated: 23-11-2001 by Superintending Engineer, Hydraulic Circle, Srinagar.
2. Whereas, Bhat Sanitation Prop: Naseer Ahmad Bhat S/o Gh. Rasool Bhat, R/o Brain Nishat, Srinagar approached this office on 03.04.2021 for withdrawal/ cancellation of the card and surrendered his original Registration Card in this office.
3. Whereas the records available (Registration Card Register) revealed that this office has issued Registration Card under No: SE/Hyd/Sgr/DEE-152/ Civil of 2001-02 in the name of Bhat Sanitation Prop: Naseer Ahmad Bhat S/o: Gh. Rasool Bhat R/o: Brain, Nishat, Srinagar.
4. Whereas the position in the matter was brought to the notice of the Chief Engineer (R&B) vide this office letter No: DSEHS/356-57 dated: 12-04-2021 with an inadvertent mistake of Civil and Sanitary in place of Civil and simultaneously further instructions in the matter were sought from the Chief Engineer Kmr I&FC Department Srinagar in view of the case under investigation/ verification in ACB.
5. Whereas Chief Engineer Kmr I&FC Department Srinagar vide his No: CE/I&FC/PS/244 dated: 17-04-2021 directed this office for suspension of the card forthwith and also to request the Chief Engineer R&B Department for similar necessary action with regard to the card issued by his office.
6. Whereas vide this office letter No: DSEHS/721-22 dated: 24-04-2021 the matter was taken up with Chief Engineer R&B Department for suspension of the card issued by him.

Now, therefore, in view of above it is hereby ordered that the contractor card in the name of Bhat Sanitation Prop: Naseer Ahmad Bhat S/o: Gh. Rasool Bhat R/o: Brain, Nishat, Srinagar bearing No: SE/Hyd/Sgr/ DEE-152/ Civil and Sanitary of 2001-02 and endorsement No: 6292-93 dated: 23-11-2001 claimed to have been issued by Superintending Engineer, Hydraulic Circle, Srinagar is hereby suspended forthwith.
