1. The bids shall be deposited in electronic format on the departmental website www.jktenders.gov.in

2. The bids uploaded on the web site up to date and time will be opened on **22.09.2021** at **11.00A.M** in the office of the Executive Engineer FC Division Anantnag in presence of the bidders who wish to attend. In case of holiday or office

- happening to be closed on the basis of opening of the bid, the same will be opened on the next working day at the same time and venue.
3. Bids must be accompanied with cost of tender document in the shape of E-Chalan (**Under M.H. 0701 and 0702**) /Treasury Receipt infavour of Executive Engineer Flood Control Division Anantnag payable at Anantnag and earnest money / BID security in shape of CDR/FDR pledged totender receiving Authority after opening of tenders, the bids for the work shall remain valid for a period of 90(Ninety) days from the date of opening of bids.
 5. The earnest money shall be forfeited if-
 - I. Any Bidder / Tenderer withdraws his Bids / Tender during the period of BID validity or makes any modification in terms and conditions of the BID.
 - II. The contractor fails to execute the agreement within 10 days after fixation of contract.
 6. Instruction to bidder regarding e-tendering process :- Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual" on website www.jktenders.gov.in acquaint bid submission process.
 - b. To participate in bidding process bidders have to get Digital Signature Certificate (DSC) as per information Technology Act 2000
 - c. Bidders can get Digital Signature certificate from approved vendors.
 - d. The bidders have to submit their bids online in electronic format with digital signature. No financial bids will be accepted in Physical form.
 - e. Bids will be opened online as per time schedule mentioned in Para -3
 - f. Bidders must ensure to upload scanned copies of all necessary documents like CDR/PAN/TIN/ E-Chalan / Registration Card fully renewed and hard copies thereof physically to tender receiving authority before date of opening of Bid.
 - g. **Note:- Scan All Documents on 100Dpi with black and white options.**
 7. The department will not be responsible for delay in online submission due to any reason.
 8. Scanned copy of cost of tender document in shape of demand draft in favour of Executive Engineer Flood Control Division Anantnag and earnest money bid in shape of CDR and FDR pledged to tender receiving authority must be uploaded with the bid original demand draft (Cost of Tender Document) latest GST clearance.
 9. Contractor / Bidder who fails to submit the hard copies for their uploaded tenders will be debarred from participating in the Tendering process for a period of Six Months (06 Months) in the first instance. Their online uploaded tenders will not be Considered for the said period.
 10. The Bid security Deposit @ 3% for the work shall be forfeited :-
If the 1st lowest tendered not attend divisional office for negotiation/completion of work as per specified date/ Remittance of CDR after works out 1st Lowest tenderer.
 11. Nothing should be paid on account of Dewatering / Diversion though involved at site.
 12. **The Tenderer who wish to participate in the tendering process should attach all important documents viz. sales Tax clearance of current quarter, TIN , PAN, duly renewed for the current financial.**
 13. **E-Challan shall be accepted which has been utilized by the participant Contractors for the NIT No. 07 of 2021-2022. However, the contractors other than the participating in original NIT i.e. 07 of 2021-2022 who wish to participate in bidding process may be fresh E-challan from Publishing date to End date of the fresh NIT.**
 14. **Bid declaration Form with E-Stamp /Witness/ Seal and signature of concerned Bidder shall be uploaded separately for each work.; Any deficiencies if observed during opening of tender the committee is empowered to cancel such tender.**
 15. **Executive Engineer is powered to cancel (As per PWD Form-25 Double) any item or items without assigning any reason thereof.**
