2. The bids shall be deposited in electronic format on the departmental website www.jktenders.gov.in
3. The bids uploaded on the web site up to date and time will be opened on **03.09.2018 at 1.00 P.M** in the office of the Executive Engineer FC Division Anantnag in presence of the bidders who wish to attend. In case of holiday or office happening to be closed on the basis of opening of the bid, the same will be opened on the next working day at the same time and venue.
4. Bids must be accompanied with cost of tender document in the shape of E-Chalan/Treasury Receipt in favour of Executive Engineer Flood Control Division Anantnag payable at Anantnag and earnest money / BID security in shape of CDR/FDR pledged to tender receiving Authority, the bids for the work shall remain valid for a period of 90 (Ninety) days from the date of opening of bids.
5. The earnest money shall be forfeited if:-
- I. Any Bidder / Tenderer withdraws his Bids / Tender during the period of BID validity or makes any modification in terms and conditions of the BID.
 - II. The contractor fails to execute the agreement within 10 days after fixation of contract.
6. Instruction to bidder regarding e-tendering process :- Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual" on website www.jktenders.gov.in acquaint bid submission process.
- a. To participate in bidding process bidders have to get Digital Signature Certificate (DSC) as per information Technology Act 2 000
 - b. Bidders can get Digital Signature certificate from approved vendors.
 - c. The bidders have to submit their bids online in electronic format with digital signature. No financial bids will be accepted in physical form.
 - d. Bids will be opened online as per time schedule mentioned in Para -3
 - e. Bidders must ensure to upload scanned copies of all necessary documents like CDR/PAN/TIN/ E-Chalan / Registration Card fully renewed.
- Note:- Scan All Documents on 100Dpi with black and white options.**
7. The department will not be responsible for delay in online submission due to any reason.
 8. Scanned copy of cost of tender document in shape of E-Challan/ Treasury Receipt in favour of Executive Engineer Flood Control Division Anantnag and earnest money bid in shape of CDR and FDR pledged to tender receiving authority must be uploaded with the bid original demand draft (Cost of Tender Document).
 9. The CDR uploaded for the work shall be forfeited :-
 10. If the ist lowest tenderer not attend divisional office for negotiation/completion of work as per specified date/ Remittance of CDR after works out Ist Lowest tenderer.
 - 11 Nothing should be paid on account of Dewatering / Diversion though involved at site.
 - 12 **The Tenderer who wish to participate in the tendering process should attach all important documents viz. sales Tax clearance of current quarter, TIN , PAN, duly renewed for the current financial.**
