- 15-14. **Test:-** The contractor shall be solely responsible for carrying out the mandatory tests required for the quality control at his own costs.
- 15-15. **Termination:-** The employer may terminate the contract if the contractor cases a fundamental breach of the contract.
- 15-16. Fundamental breach of contract will include:-
 - (a) Continuous stoppage of work for a period of 30 days without authorization of Engineer in-Charge.
 - (b) Pursuant to the process of termination of defaulted contract, the employer reserves the right to invite fresh tender for the balance work at the risk and cost of defaulter contractors.
 - (c) If the case contactor failed to start/ complete the work, within the stipulated time period, his CDR/Earnest Money shall be fortified after termination of the contract. Besides, defaulting contractor shall be debarred from taking works in Irrigation & Flood Control Department at least for one year.
