1. The tender documents shall be issued only to such intending tenderer who produces TIN No, latest Sales Tax Clearance Certificate, valid Registration Card and CDR for the particular work for which he wishes to cast tender.
2. The tender should be accompanied with CDR for the amount shown above from any scheduled bank pledged to the tender receiving authority.
3. The rates quoted should be covered with transparent tape. Corrections, if any, should be authenticated by signature.
4. The successful tenderer shall have to start the work within 2 days after the date of issue of letter of intent or allotment, failing which action under rules shall be taken against him.
5. The contractor will not be allowed to sublet work to any other agency.
6. The tender should be sealed in an envelope with name of work super-scribed
7. Rates of departmental materials as shown in the rate list shall be applicable during currency of the contract
8. The tender opening authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
9. No extra charges what so ever shall be paid on account of dewatering, construction of diversion bund, ramps, roads required during execution. The offered rates shall be inclusive of such charges.
10. In case the successful tenderer fails to start execution of the work within two days after issuance of allotment/ letter of intent, the work shall be got executed through some other agency or means at his risk and cost without issuing any notice or reminder.
