6. The tender should be sealed in an envelope with name of work super-scribed
7. Rates of departmental materials as shown in the rate list shall be applicable during currency of the contract
8. The tender opening authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
9. No extra charges what so ever shall be paid on account of dewatering, construction of diversion bund, ramps, roads required during execution. The offered rates shall be inclusive of such charges.
10. In case the successful tenderer fails to start execution of the work within two days after issuance of allotment/ letter of intent, the work shall be got executed through some other agency or means at his risk and cost without issuing any notice or reminder.
11. The successful tenderer shall have to abide by the conditions as laid down in PWD form -25.
12. The successful tenderer shall have to draw the agreement with the department simultaneously at the time of issuance of allotment and shall have to produce the valid enlistment card for recording the work in his registration card.
