The agency should possess sufficient experience, men and machinery like, Hydraulic excavators or pock lanes at least one number, Loaders or Tippers at least one number, Roller/ compactor at least one number. The Agreement/ MoU on an affidavit for chartered or hired machinery expressing consent of owners of the hired machinery along with attested copy of ownership should be enclosed with the tender Cover-I, if same is not available with the tenderer.

Besides amount as shown against each work in the tender document/BOQ (Minimum Cost of wood @ 10% of evaluated amount as communicated by the CHO Bandipora) on account of cutting down of fruit bearing trees of various girths including removal of roots , stacking, loading , unloading & clearance of site has to be deposited by the contractor before start of the Work in the shape of the e–Challan/Treasury Challan/ receipt/ Demand Draft/ GR, however the materials got thereby in the shape of wood shall be property of the contractor & to be disposed by him without any delay. The fruit trees have already been identified by the department.

The General scope of the work shall be as per **Annexure –I.**

2. 00 ELIGIBILTY CRITERIA FOR ISSUING TENDER DOCUMENTS:-

2.1 Full Bio-data of the bidder should be uploaded separately as per annexure-XII enclosed.

CRITERIA FOR PARTICIPATION OF TENDERS:-

2.2 TECHNICAL

- I. The contractor should posses the experience certificate along with allotments having successfully completed works during last five years ending 31/03/2018 which should be any one of the similar nature works:
 - i. <u>Similar Works means</u>: Earth work of all sorts, River Training Works, , Earthen storage tank, Road /drainage Works (in road/ drainage works the amount of earth work item should be minimum 40% of the allotted Cost).
- a. One similar completed work costing not less than 80% of advertised cost during the last **five** years.
- **b.** Two similar completed works costing not less than 50% of advertised cost each during the last **five** years.
- c. Three similar completed works costing not less than the 40% of advertised cost during the last **five** years.

2.3 FINANCIAL CRITERIA:-

I. As a proof of sufficient financial capacity, the tenderer/s should have an average annual turnover of at least 30% of advertised cost, which shall be calculated for the best three years out of last five years ending on 31st March 2018.

Note: a) Certified Annual reports / Turn over including profit and loss statement, account checked & issued through a Chartered accountant to be annexed/ Uploaded with Cover-I.

b) Valid GST No, latest GST return and PAN No.

2.4 Joint Ventures

2.4.1 Technical Criteria

- i) Any member or members of Joint Venture should have satisfactorily completed at least one work of similar nature work costing not less than 80% of advertised cost during the last 5 years ending on 31.03.2018.
- **d. ii)** Two similar completed works costing not less than 50% of advertised cost each during the last **five** years.
- e. iii) Three similar completed works costing not less than 40% of advertised cost during the last five years.
- iv) Any member or members of the joint venture must have experience as required as per Para 2.1 & 2.2 a, b, c.

2.4.2 Financial Criteria

- i) The arithmetic sum of average annual turnover of all members of the Joint Venture in last five year ending on 31.03.2018 should be more than 30% of the advertised Cost.
- ii) Average annual turnover shall be calculated for the best three years out of last five years ending on 31st March 2018.
- Note: a) Certified Annual reports / Turn over including profit and loss account statement checked & issued through a Chartered accountant to be annexed / Uploaded with Cover-I.
 - b) Should be a profit earning firm /company for the preceding two years.
 - c) Joint Ventures are acceptable, with leading partner's minimum share 55 % and in overall 100%.
 - d) Valid GST No, latest GST return and PAN No.
- 2.4.3 All the members of joint venture shall be jointly & severally responsible for all the acts done on behalf of joint venture & tender bid shall be jointly signed by the all members of the joint venture or their authorized representative so as to legally bind them jointly & severally. All tenders must be submitted with a copy of Joint Venture agreement duly registered by the First Class Judicial Magistrate.
- **2.4.4** All above criteria must be satisfied by the joint venture to qualify for opening of their Price bid. **Notes:**
 - i. Participation of registered/ active Self Help Group (SHG) of engineers in the tendering processing shall be regulated as per the Govt. order No. 14-L&E of 2017 dated: 20/02/2017 issued by the Labour and Employment Department J&K State. Further the JV/ Consortium can be formulated among the SHG's only. The JV/ consortium formulated outside SHG's shall be rejected and only SHGs registered and active in District Bandipora shall be allowed to participate in the said e-NITs.
 - ii. The lowest bidder of the previous e-Nit No:- 04 of 2018-19 dated:- 08-09-2018 , who neither deposited additional security deposit as required in case of below rates nor submitted the original documentary evidence for verification even after issuing notices vide this office No;-FSCDN/CS/4437-42 dated:-29-9-2018 & No ;- FSCDN/DB/4617-21 dated:-6-10-018 is debarred from participating in any form i.e. individual or joint venture in this fresh e-Nit .
 - iii. Works are considered similar such as earthwork of Sorts, Protection work, Earthen storage tanks, River Training Works, Road /drainage Works (in road/drainage works the amount of earth work item should be minimum 40% of the allotted Cost).
 - iv. Deleted.
 - v. The contractor should submit performance certificate in reference to para.2.3 & 2.4.1 above from the client for having successfully completed similar works in last 5 years.
 - vi. There should not be any unsatisfactory performance report of the contractor from any source.
 - vii. Any tenderer can participate in the same tender in one entity only i.e. individual firm/company or a JV with other firms/companies. In case, any tenderer submit their offer in more than one entity for same tender, such offer shall be liable to be rejected.

- viii. The bidders who participate in more than one bid & in a peculiar situation if the bidder is found as lowest bidder for more than one bid works shall have to produce agreement/ MoU that they have sufficient machinery Like Hydraulic excavators, dumpers/ tippers before issuance of allotment/ five days after opening of the Price Bid, whichever is earlier to complete all such works within the stipulated time. Bidder will have to start the bid works simultaneously for every allotted bid work, no excuses shall be acceptable in this regard.
 - ix. All communications Served through email, whatsapp, registered post on present address shall be considered to have been delivered to the agency once posted through the means mentioned above & no claim shall be accepted on this account.

The e-tender so uploaded shall be accompanied with a e-Challan or Treasury Challan/ Receipt remitted to the MH: 0702 Rev. Misc. in favour of Executive Engineer Flood Spill Channel Division Narbal towards the cost of the tender documents (non transferable/Non refundable) as shown against each work above in the e-NIT, which shall not be refunded and shall be submitted upto the date mentioned above. No other form other than e-Challan shall be accepted/entertained.
- 4.0 You are requested to visit the site of work to familiarize yourself with the Site conditions:-
- 5.0 SUBMISSION OF TENDER:-
- 5.1 The e-tender documents of conforming proposals shall be uploaded in two separate Covers viz. Cover-I containing Technical Bid (Volume I) of tender and submission of tenderer/s and Cover-II containing Price Bid (Volume II). Detailed credentials as per the requirement of eligibility criteria for participation in Tendering process and all tender papers including detailed statements as mentioned in the following chapters are to be submitted in "Technical Bid". All conditions, both technical as well as financial/commercial shall be given in technical bid only. No condition should be quoted in the Price Bid containing Statement of advertised Quantities with rates duly filled in.
- 5.2 Technical as well as Price bid shall be uploaded separately under specified.
- 5.3 Bids must be accompanied with cost of tender document in shape of e-Challan or Treasury Challan/ Receipt remitted to the MH: 0702 Rev. Misc. in favour of Executive Engineer, Flood Spill Channel Division, Narbal (Tender inviting authority) & No other form other than e-Challan shall be accepted/entertained and earnest money / Bid Security in shape of CDR/ FDR/ irrevocable BG pledged to Executive Engineer, Flood Spill Channel Division Narbal.
- To participate in bidding process, bidders have to get "Digital Signature Certificate (DSC)" as per information Technology Act 2000.
- 5.5. Bidders can get digital certificate from any approved vendor. The bidders have to submit their bids online in electronic format with digital signature. No. financial bid will be accepted in physical form.
- 5.6 Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual Kit" on Website http://www.jktenders.gov.in acquaint bid submission process.
- 5.7 Bids must ensure to upload scanned copy of all necessary documents with bid. Besides original/photocopies of documents related to the bid be submitted physically/be registered post/through courier before the date specified

- a).In case of lowest bidder is found unbalanced i.e. below than advertised cost, the bidder shall have to produce additional performance Security within a period of seven (07) days after opening of Price bid in any shape CDR/ FDR/ Irrevocable Bank Guarantee from any Scheduled or Nationalized Bank as per following break-up which shall be released only after completion of work in all respects. No further reminder shall b give to bidder & work shall be put to fresh tenders or allotted as per codal procedures.

- **b).** The successful bidder (L1) shall have to produce the original documents with a period of 05 (Five) days & in case of failure of producing the same the tenders will be put to fresh or allotted as per the codal procedures.
- **5.10** The Bidders will firmly note that the above items of work involved for aforesaid Work(s) Shall include but not limited to the following:-
- a. Excavation and disposal of all types of soils and rocks from open excavation etc.
- b. Nallah diversions.
- C. All safety arrangements as per relevant IS, IRC and IRS Codes of practice and as specified in the tender documents.
- d. Construction of all access roads as required to different construction spots and Construction of all temporary diversions of roads, laying of temporary Pipe crossings, maintenance of all roads and dismantling same after completion & making same good.
- e. Constructions of all temporary cross drains as required and construction of all temporary diversions of streams/Nallah/Canals, maintenance of all diversions etc. as per site conditions and as directed by the Engineer
- f. Provision of quality control including providing of required tests, charges of which to be borne by the contractor. Fixed Polythene sheet and shall be responsibility of the Contractor Submission of progress photographs (digital), vediographic record/Drone shoots through the professional person before, during & after construction and progress reports in both hard and soft copies. Taking Cross-Sections, L-sections by Auto Level / ETS before and
- i. After execution. Preparation of work abstract of executed work, preparation of Bills. The information and data stated and incorporated in tender document elsewhere is for the General guidance only and may vary as a result of more detailed construction drawings and as per site requirements. The project being time bound and important, and any of aforesaid assignment not done within two (02) Days from issuance of notice shall be got done through the concern professionals and their payment be paid to them be debit to the concern work without giving any further notice.
- j. Providing of First Aid medical facilities to the Labourers, working staff at site of work in addition as mentioned at above site(s) & the insurance as well.
- 6.0 Tenders will be opened online as per time schedule mentioned in the office of Executive Engineer, Flood Spill Channel Division Narbal on the day as mentioned in the schedule referred on Top Sheet above or on any subsequent working day, (which shall be informed through e-mail, fax) in presence of such tenderers or the authorized representatives who wish to remain present at the time of opening of tenders Initially only the technical bids shall be opened and will be evaluated.
- **7.0** The Price Bids shall be opened online too only after assessing suitability of offers as per technical bids **by Executive Engineer**, **Flood Spill Channel Division Narbal**. The opening of Price bids shall be intimated to the qualified tenderers.
- **8.0** Tender shall be uploaded as per "Instructions to Tenderers" forming part of the tender document.
- **9.0** A firm /company or joint venture will upload his/their tender either as individual firm/company or as joint venture only. In case any firm/company submits his/their Price bid both as individual firm/company and as JV with other firm/company, both the offers shall be considered as invalid.
- 10.0 In case of JVs having common partner/s shall upload their bid under one JV only. In case bids are received from more than one JV having common partner/s, their offers shall be considered as invalid.
- 11.0 If it is found that any tenderer/s has/have furnished misleading/wrong or fraudulent information/documents, his/their tender shall not be considered and the EMD/ of the tenderer/s will be forfeited.
- **12.0** If the documents/information submitted is found to be wrong /fraudulent at any stage after award of work, the contract may be terminated and the work shall be executed at the risk and cost of the Tenderer /contractor.
- **13.0** e-Tender received without Earnest Money in the form and value specified in the tender document shall be summarily rejected.
- **14.0** The Executive Engineer, Flood Spill Channel Division Narbal reserves the right to postpone the tender submission/opening date and to accept/reject any or all tenders

without assigning any reasons thereof. The decision of the **Executive Engineer**, **Flood Spill Channel Division Narbal** after assessment of suitability as per eligibility criteria shall be final and binding.

- 15.0 The validity of the offer shall be 90 days from the date of opening "Price Bid".
