Bids must be accompanied with earnest money in shape of CDR/ FDR (the date on these instruments must not be prior to date of issuance of this tender Notice) and cost of tender document (Non- Refundable/ Non- transferrable) under MH: 0702-Rev. Misc. in shape of Treasury Challan / receipt or e-Challan (mentioning therein NIT No, S No of work and Adv. Cost of work) to be pledged in favour of the Executive Engineer Flood Spill Channel Division Narbal.
- 3. The bids for the work shall remain valid for a period of 90 days from the date of opening of Price bids.

#### 4. The earnest money shall be forfeited if:

- 4.01 Any bidder / tenderer withdraws his bid/ tender during the period of bidvalidity or makes any modifications in the terms and conditions of the bid.
- 4.02 Failure of Successful bidder to furnish the required additional security money within the specified time limit of Seven days from the date of notification of same to the bidder by the tender opening authority.
- 4.03 Failure to produce the original documents necessary for verification on declaration of the lowest bidders on which bidder was qualified by orbefore 07 days of the opening of Price Bid / generation of comparative statement.
- 4.04 Failure of Successful bidder to execute the agreement within 15 days after fixation of contract.

## 5. Instructions to bidders regarding e-tendering process.

- 5.1 Bidders are advised to download bid submission manual form the "Downloads" option as well as from "Bidders Manual Kit" on website www.jktenders.gov.in acquaints bid submission process.
- 5.2 To participate in bidding process, bidders have to get 'Digital Signature Certificate (DSC)' as per information Technology Act- 2000. Bidders can get digital certificate from any approved Vendor.
- 5.3 The bidder has to submit their bids online in electronic format with digital signature. No bid will be accepted in physical form.
- 5.4 Bids will be opened online as per time schedule mentioned in above at S. No.
- 5.5 Bidders must ensure to uploads scanned copy of all necessary Documents.

#### Note: Scan all the documents on 100 dpi with black and white option.

- 6. The department will not be responsible for delay in online submission of tender due to any reason/ reasons.
- 7. Scanned copy of cost of tender documents in shape of e-challan or Treasury challan/ receipt and earnest money in shape of CDR/ FDR pledged to the Executive Engineer Flood Spill Channel Division, Narbal, enlistment card duly renewed, G. S. Tin No., latest GST Return certificate.

#### 8. Special Conditions: -

- a) Price escalation and Taxes: The item wise cost / offer be quoted by the bidder entirely in Indian Rupees and the cost quoted shall be deemed to include price escalation and all taxes till completion of work. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill of the contractor as per the rates prevailing at the time of recovery.
- b) The bidder should upload the latest GST return & the payments will also be made subject to the production of latest GST returns.
- c) Bidders are advised to use "My Document" area in their uses on JK tenders e-Tendering portal to store such documents as are required.
- d) The bidder shall have the experience of having executed such nature of works i.e. water retaining structures.

e) **Unbalanced Bid:** In case bid of the lowest bidder is found unbalanced i.e. below than advertised cost, the bidder shall have to upload additional performance security in advance in any shape CDR / FDR as per following break-up, whichshall be released only after successful completion of work:-

- f) Restoration of work: On completion of contract the contractor shall be responsible to remove all un-used material and restore all work in its original position at his own cost, any damage if caused during execution of work shall be restored by the contractor at his own cost.
- g) The contractor has to manage housing for labours, electricity, water storage for material, watch and ward and other facilities at his own.
- h) **Arbitration:**The Arbitration and conciliation Act,1996 shall be deemed to apply to the arbitration, disputes, if any regarding reference to Courts shall besubject to the jurisdiction of the J&K Courts only
- i) **Defect Liability Period (DLP):** The contractor should be responsible to maintain the work within a defective liability period of Six (06) months.
- j) Safety: The contractor shall be responsible for safety of all activities at site of work during execution.
- k) **Termination:** The employer may terminate the contract if the contractor causes any fundamental breach of the contract, which shall include stoppage of work without any reason.
- Nothing shall be paid to the contractor on account of dewatering, diversion Nallah if involved at site.
- 9. **Specification / Quality Control**: All items of works shall confirm to specifications as per MORTH/BBO/CPWD/SSR/ any other prescribed specifications.
- 10. **Departmental Stores:**The departmental Store Shall be deducted on the following rates;
  - a) Empty Cement Bags= ₹6.80/Bag.
- **10.1.** If the departmental material is not available in the divisional store the agency/contractor may purchase the said material from market with standard specification, and shall get the same certified by the Assistant Executive Engineer concerned.

- 11. **Penalty for Delay on account of Contractor:** in case of delay not justified & caused due to the faults of the Contractor a penalty upto max. of 0.05% of the contract value will be imposed.
- 12. If the contractor fails to complete the work within the stipulated period the work shall be got executed by the Department by other means on the risk and cost of the contractor.

All other terms and conditions as laid down in the PWD Form 25 Double shall also remainin force.
