4. The successful tenderer shall have to start the work within 2 days after the date of issue of letter of intent or allotment, failing which action under rules shall be taken against him.
5. The contractor will not be allowed to sublet work to any other agency.
6. The tender should be sealed in an envelope with name of work super-scribed
7. Rates of departmental materials as shown in the rate list shall be applicable during currency of the contract.
8. The tender opening authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
9. No extra charges what so ever shall be paid on account of dewatering, construction of diversion bund, ramps, roads required during execution. The offered rates shall be inclusive of such charges.
10. In case the successful tenderer fails to start execution of the work within two days after issuance of allotment/ letter of intent, the work shall be got executed through some other agency or means at his risk and cost without issuing any notice or reminder.
