3. *The rates quoted should be covered with transparent tape. Corrections, if any, should be authenticated by signature.*
4. *The successful tenderer shall have to start the work within 2 days after the date of issue of letter of intent or allotment, failing which action under rules shall be taken against him.*
5. *The contractor will not be allowed to sublet work to any other agency.*
6. *The tender should be sealed in an envelope with name of work super-scribed*
7. *Rates of departmental materials as shown in the rate list shall be applicable during currency of the contract.*
8. *The tender opening authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.*
9. *No extra charges what so ever shall be paid on account of dewatering, construction of diversion bund, ramps, roads required during execution. The offered rates shall be inclusive of such charges.*
10. *In case the successful tenderer fails to start execution of the work within two days after issuance of allotment/ letter of intent, the work shall be got executed through some other agency or means at his risk and cost without issuing any notice or reminder.*
