General Terms and Conditions of Contract:-

1. The contractor who applies for issuance of tender document shall have to produce the requisite CDR at the time of applying for issuance of tender document for the particulars work. Without CDR no application will be accepted and no tender document shall be issued.
2. The intending tenderer are advised in their interest to visit the site to assess fully the work and working conditions before tendering. Any clarification shall be sought before submission of tenders.
3. Tender documents should be sealed in proper cover with Name of Contractor & as prescribed in this NIT.
4. Intending contractor should ensure before tendering that the requisite men & machinery is readily available with them. No excuse on this account shall be accepted.
5. The tenders should be accompanied by call deposit receipt in the shape of CDR pledged to the tender receiving authority shown against each work without which the tenders shall be rejected. Once used C.D.R's cannot be entertained.
6. The rate quoted by the contractor should be taped with transparent tape. Any tender form having over writings on the quoted rates should be signed failing which the same shall be rejected. The rates written in words shall prevail in case of any error or cuttings.
7. The tender opening authority reserves the right to accept or reject any one or all tenders without assigning any reason therefore.
8. No extra charges what so ever shall be paid an account of dewatering, construction of diversion bund and ramps, roads required during excavation. The offered rates shall be inclusive of such charges.
9. Time is the essence of the contract. The work shall have to be completed within stipulated time what so ever the conditions. No extension in time of excavation will be allowed.
10. In case the successful tenderer fails to start/execution the work within specified time as mentioned in the NIT after issuance of allotment. The work shall be got executed through some resourceful agency at his risk and cost without issuing any notice or reminder.
11. Contractor is bound to start the work within seven days from the date of issue of allotment and is bound to complete the same within stipulated period of time. If the lowest tenderer fails to start the work, no further notices shall be served. His CDR shall be forfeited immediately and blacklisting of his Registration card, shall be recommended.
12. The contractor shall have to make reasonable & timely payments to all labours engaged by him, should the Executive/Assistant Executive Engineer will pay the labourers by debits/dues of the contractor. The labour act will be applied on the contractor.
13. If any item/s of the work not included in the advertised rate list is found necessary to be executed, these will be paid according to the sanctioned schedule of rates in force in Irrigation & Flood Control Department at the time of fixing of the contract plus or minus the contractor's allotted tender appreciation/depreciation. Rate for items not include in the sanctioned schedule of rates will be allowed on the basis of analysis & after approval of the competent authority. Any typographical error or omission in the rate list shall be subjected to corrections as per sanctioned schedule of rates in vogue in the Department.
14. It is the duty of the contractor to sign the works register, measurement Books wherein measurements as recorded regularly & in case of his failure to do so measurements as recorded by the Department staff supervising the execution of the work viz junior Engineer & the Assistant Executive Engineer, will be final & the Executive Engineer's decision in this behalf will be binding upon the Contractor & no claim on this account will be entertained by the Department.
15. The validity of the offer shall be 90 days from the date of opening "Price Bid".
16. The transfer of tender documents purchased by one intending tenderer to another tenderer is not admissible. The tenderer can submit tenders only in the name of the tenderer to whom the documents were issued.
17. In case of any disputes/differences, the jurisdiction shall be to the Courts situated in Srinagar only.
18. The cost of departmental supplies will be deducted at prevalent stock rates.
19. In case any scanned tender document/form is found submitted by any tenderer, the case shall be recommended for penal action under forgery and blacklisting of the registration card of the tenderer.
20. Position of Funds: - Demanded.
21. It shall be mandatory for the executing agency/contractor to ensure safe and adequate supply of electricity required for all the workmen skilled/unskilled deployed at site of work.

22. Suitable arrangements for supply of potable water at site of work for all the workmen skilled/unskilled be made by the agency/contractor just before the virtual start of execution at site.
23. Arrangements for sufficient sanitation facility at site be ensured by the executing agency/contractor for all the workmen to be mobilized at site, besides, separate Toilet facilities be provided for female workers at the site of work.
24. Insurance cover as admissible under rules shall be provided to all the workers skilled/unskilled deployed at site and the necessary premiums shall be borne by the executing agency/contractor itself. Besides. compliance with the safety measures as per Safety Regulations circulated by J&K SWRAA
25. **Unbalanced tender:-** in case of tender of the lowest tenderer is found unbalanced, the successful tenderer shall have to produce additional performance security in shape of CDR/FDR/Bank Guarantee before fixation of contract as per following breakup:-
