



Terms and Conditions:-

10. The tender shall be received only on prescribed tender documents to be issued by this office from **04/12/2017 to 14/12/2017 upto (2.00 P.M)** against cash payment as shown in annexure (A) of the NIT on production of registration card dully renewed for the current financial year having requisite capacity sales tax clearance certificate, GST Registration Certificate and 2% earnest money in the shape of CDR pledged to the Executive Engineer Irrigation Const. Division Pampore.
11. In case the tenders cannot be received on due date on account of holiday or any unavoidable circumstances, the tenders shall be received on **next** working day.
12. Tenders shall be opened on the same day or any other day convenient to the tender opening authority in presence of tenderers who may wish to be present at that time.
13. The tender opening authority reserves the right to reject any or all tenders without assigning any reason thereof.
14. Nothing shall be paid on account of dewatering/ Diversion if needed during the execution of work and extraction of tree roots or falling of tree that may be encountered during execution.
15. 1% Cess on account of regulation of Employment and conditions of service Act, shall be deducted from the contractors bill.
16. If the lowest tender fails to start the work within stipulated period, no further notices shall be served to him. His CDR shall be forfeited immediately and blacklisting of his registration card shall be recommended to higher authorities.
17. All other terms and conditions shall remain same as laid down in the **P.W.D printed FORM No. 25 (double)** and enclosed annexure (B) of this NIT.


