No postal order shall be entertained and only those tenders for which documents are obtained from this division will be entertained. The rates should be guarded with transparent tape without which tenders will be rejected. The rates should be quoted against advertised units, other than that the tenders will be rejected. No correction slip will be entertained. In case the contractor fails to attend divisional office for negotiations within 06 days the work will be put to fresh tenders. The income tax / service tax as admissible shall be deducted from the bill of the contractor. The departmental material will be supplied to the contractors on prevalent stock rates at the time of issuance of the material. The works have been advertised on Sanctioned Schedule of rates 2012. Other terms and conditions as laid down in detailed NIT No. 06 of 04/2015 will also hold good. In case the rates of the lowest tenderer are found unbalanced/below the scheduled rates the contractor has to deposit the additional security deposit as per the norms in vogue
