- 1. Earnest money @2% of advertised cost in the shape of CDR from any scheduled bank pledged to Executive Engineer I&FC Division Baramulla must be attached with the application while applying for issuance of tender document.
- 2. The applicant / intending tenderer must approach in person along with his registration card and TIN No. etc. Without which he shall not be entitled to obtain tender document.
- 3. The envelope containing tenders ought to be made tamper proof by fixing its all joints properly.
- 4. One envelop must containing only one tender and should be clearly marked as <u>"TENDER FOR"</u>, (Name of work), (amount of work) and (name of contractor), without which the envelop shall not be considered as tender.
- 5. The rates quoted must be written neat and clean and must be guarded with transparent tape.
- 6. The contractor shall have to give the analysis of rates in case the rates quoted are seems not reasonable / workable.
