03. The tenders uploaded on the website up to due date will be opened on **12-09-2015 (at 12:00 Noon)** in the office of the **Tender Receiving Authority, mentioned above.**
04. The complete bidding process will be online.
05. Tenderers must be accompanied with cost of Tender Document in the shape of Demand Draft in favour of Executive Engineer, Irrigation & F.C. Division, Baramulla and Earnest money in the shape of CDR pledged to Tender Receiving Authority. The tender for the work shall remain valid for a period of 90 (Ninety) days from the date of opening of tenders.
06. The earnest money shall be forfeited if:-
  - a. Any Tenderer withdraws his tender during the period of tender validity or makes any modification in terms and conditions of the tender.
  - b. The contractor fails to execute the agreement within 10 days after fixation of contract.
07. Instructions to bidder regarding e-tendering process: Bidders are advised to download bid submission manual from the Downloads option as well as from Bidder Manual Kit on website [www.jktenders.gov.in](http://www.jktenders.gov.in) as per information Technology Act 2000. Bidders can get Digital Certificate from approved vendor.
08. Bidders have to submit their bids online in electronic format with digital signature. No financial bid will be accepted in physical form.
09. Bids will be opened online as per time scheduled mentioned in para 3.
10. Bidders must upload the scanned copy of all necessary documents like CDR/ PAN /Tin / Demand Draft / Registration Card duly renewed and has to submit hard copies of all the requisite documents physically to Tender Receiving authority up to scheduled date & time.

11. The department will not be responsible for delay in online submission due to any reasons.
12. The payment shall be made only when the funds are received by this office.
13. If the bidder does not quote rate for any item of the rate list / quantity schedule, cost of such item/items shall be deemed to be part of the overall / total contract value. No rate shall be allowed for such item/items in the allotment of contract.
