The tenderers shall have to cast their tenders on the tender documents which shall be issued to the intending tenderers from **(11/06/2015) to (13/06/2015) during Office Hours**, only on providing of CDR / TIN & on remittance of the cost of tender document in the Divisional Chest against proper G.R./ D.D. as shown against each work.

In case the last date of the receipt of tenders be a holiday or off day, the tenders shall be received on next working day up to **2.00PM**.

1. Earnest money @2% of advertised cost in the shape of CDR from any scheduled bank pledged to Executive Engineer I&FC Division Baramulla be attached with the application while putting forth for issuance of tender document.
2. The applicant / intending tenderer must approach in person along with his registration card and TIN N: etc. Without which he shall not be entitled to obtain tender document.
3. One envelop must containing only one tenders and should be clearly marked as "TENDER FOR", Name of work, amount of work and name of contractor without which the envelop shall not be considered as tender.
4. The envelope containing tenders ought to be made tamper proof by fixing all joints by fixing transparent tape over it.
5. The contractor shall have to give the analysis of rates in case the rates quoted are seems not reasonable / workable.
6. The works put to tenders are of urgent nature as such any laxity shown by the successful tenderer in executing the work in time & to the best satisfaction of the supervisory staff / officers shall not absolve the contractor from contractual obligations.
7. Any typographical error or omission found in the rates / unit shall be paid strictly as per the sanctioned schedule of rates.
8. The cement shall be issued from the Divisional Store against cash payment as per the stock rate Rs.400 / Bag and Steel Rs.5100 / Qtl. And crates @Rs.17/Sft.
9. No payment shall be made on account of construction of ring bund /diversion bund / cross bund or dewatering etc.
10. The concrete work will have to be got tested under Cube Testing System of 7 days / 28 days through any reputed institute. The charges of testing shall borne by the executing contractor.
