For & behalf of the Governor of J&K state sealed tenders affixed with revenue stamps worth Rs 6/= are invited from the registered firms/contractors for the works indicated below to this N.I.T and the prescribed documents to be obtained from the office of the Executive Engineer, Irrigation & Flood Control Division Srinagar, SDA building near Police Control Room Srinagar against cash payment as shown in the annexure "A". The tenders should reach the office of the tender opening authority shown as per N.I.T on prescribed date upto 2 P.M & shall be opened on the same date or any subsequent date convenient to the tender opening authority in presence of the tenderers who may choose to be present. The opening authority reserves the right to reject any or all tenders without assigning any reason thereof.

1. The tenders should be accompanied with a call deposit receipt equivalent to 2% cost of the work from any bank pledged to tender receiving/opening authority.
2. A tenderer can participate in tendering process within his enlistment capacity and tender document will be issued to his capacity amount only.
3. The successful tenderer shall have to start the execution of the work within three days after the date of issue of letter of intent or allotment.
4. The tenderers should cover the rates quoted with a transparent tape and avoid corrections.
5. The documents shall be issued to only such contractors who produce Tin No. (in original), latest sales tax clearance certificate, valid registration card without which no document shall be issued.
6. The contractor will not be allowed to sub-let work to any other agency.
7. In case any sort of un-certainty prevails on the date of receipt of tenders, the tenders shall be received on the next working day.
8. Full details can be had from the office of the Executive Engineer, Irri. & Flood Control Division, Srinagar SDA Building near Police Control Room before the last date of issue of tender documents on all working days from 10:00 A.M to 2 :00 P.M
9. Unqualified tenders which does not complete the terms and conditions of NIT shall straight way be rejected.
- 10 If the tenderer does not quote rate for any item of the rate list/qty schedule, such item/items shall be deemed to be part of the overall/total contract value and no rate shall be allowed for such item/items.
