## SHORT TENDER NOTICE No. 01 of 2015-16

For and on behalf of Governor of Jammu & Kashmir state sealed tenders valid for 90 days affixed with revenue stamps worth Rs. 4/- are invited from registered PWD contractors/ registered Self Help Group of Engineers of all Engineers wings of the classes mentioned against each work in the enclosed annexure "A" to this NIT whose enlistment card are valid and free for the capacity of the work and to whom all the terms and conditions of Master NIT / detailed tender documents / PWD form 25 (double are acceptable)

The tenders be addressed to the Executive Engineer Irrigation and Flood Control Division Sopore and should reach to this office on or before 21-04-2015 up to 2 pm through registered post or by hand . The tenders will be opened on the same day or any other date convenient to the Executive Engineer in presence of the intending tender who may like/wish to be present. In case last date of receipt of tenders be a holiday or off day the tenders will be received on next working day up to 2 pm through registered post or by hand.

The tenderers shall have to cost their tenders on the tender documents to be issued in favour of intending tenderer form 17-04-2015 to 18-04-2015 up to 3 pm only on production of valid registration card holder himself and on remittances of cost of tender documents shown against each work in the enclosed annexure "A" to the NIT in question in to the divisional chest of Executive Engineer Irrigation and Flood Control Division Sopore against proper GR.

Earnest money should be attached with the application in the shape of call deposit receipt issued from any scheduled bank @ Rs. 2% of advertised amount, without which no tender document shall be issued.

The tenderer shall have to quote his rates legibility and should be signed underneath of rates and transparent cello tape should be fixed on the rates / amount.

Late tender, if any, received by the receiving authority shall not be entertained at all and shall be rejected out rightly.

The envelopes containing tenders shall be made tamperproof by sealing all joint properly with transparent tape to it.

One envelope must contain only one tender and should be clearly marked as tender for: Name of work, name of Contractor (sender) amount of work, without which the envelop shall not be considered as tender container. Payment shall be made only when funds are available from the competent authority.

The rates should be quoted / written both in words as well as figures without corrections / over writings duly transparent tape fixed.

The agency / tenderer shall have to give the analysis of rates in case the rates are not reasonable or workable.

Nothing extra on account of dewatering and diversion shall be paid even if involved at site once or repeatedly Further more nothing extra shall be paid on account of extraction of tree roots. The contractors should quote their rates inclusive of dewatering, diversion & extraction of tree roots and any other unforeseen item required for completion of the work.

The allotments shall be issued and payment shall be made after receipt of funds from the higher authorities against the head of account.

Time being essence, the work shall have to be completed within the stipulated period. As such any laxity shown by the successful tendered in execution of work to the best satisfaction of supervisory staff / officers, shall not absolve him from the contractual obligations.

Extra cost involved due to laxity of contractor if department gets the work completed any part or full departmentally shall be deducted from contractors work done bills.

For any delay the contractor will have to pay Rs. 1000/ day as penalty if he fails to complete the work within the stipulated period. Any typographical error emissions found in the rates / unit shall be paid strictly as per the sanctioned schedule of rate 2012.

As per SRO – 18 of 27-04-2010 all the agencies executing works contracts irrespective of class have been brought under the ambit of service tax and the rates of service tax/ Income Tax at vogue including Cess 1% Shall be charged.

**Special Conditions:-**

- 1. The contractor is bound to start the work immediate after issue of allotment /letter of intent and is bound to complete the same within stipulated period of time. If the lowest tenderer fails to start the work, no further notices shall be served. His CDR shall be forfeited immediately and blacklisting of his Registration card, shall be recommended.**
- 2. The contractor who applies for issuance of tender document shall have to produce the requisite CDR at the time of applying for issuance of tender document for the particular work. Without CDR no application will be accepted and tender document shall be issued.**

All other terms and conditions shall remain same and operative as laid down in the detailed master NIT / detailed tender document / PWD form 25 double.
