- The tenderers should cover the rates quoted with a transparent tape and avoid corrections.
- The documents shall be sold to only such contractors who produce Tin No. (in original), latest sales tax clearance certificate, valid registration card and CDR of the particular work for which he wishes to cast his tender.
- The contractor will not be allowed to sub-let work to any other agency.
- In case any sort of un-certainty prevails on the date of receipt of tenders, the tenders shall be received on the next working day.
- Full details can be had from the office of the Executive Engineer, Irri & Flood Control Division, Srinagar SDA Building near Police Control Room before the last date of issue of tender documents on all working days from 10:00 A.M. to 2 P.M.
- Unqualified tenders which does not compete the terms and conditions of NIT shall straight way be rejected.
- If the tenderer does not quote rate for any item of the rate list/qty schedule, such item/items shall be deemed to be part of the overall/total contract value and no rate shall be allowed for such item/items.
