

NOTICE INVITING BIDS 2014-15

For & on behalf of the Governor of J&K State sealed bids affixed with Revenue stamps worth Rs.5/= are invited from the interested parties for removal of shoal from River Jhelum as per the details given below. The bid should reach the office of the Chief Engineer, Kashmir , Irrigation & Flood Control Department Srinagar on or before 09/3 /2015 upto 2 :00 P.M & shall be opened on the same or any subsequent date convenient to the opening authority in presence of the bidders who may choose to be present at the time of opening of the bid.

Terms and Conditions:-

01. The bidders should quote lump sum bid amount only against the reserved minimum bid amount shown against item. Further the successful bidder shall have to pay royalty charges to Geology and Mining Department as per their norms.
02. Earnest money in the form of call deposit receipt of any scheduled bank pledged to the bid receiving authority, should accompany the bid.
03. The quantity of depositions as shown above, though tentative, is the maximum that can be allowed to be lifted within the quoted /accepted bid amount. Cutting shall be as per deposition profile at the time of start of actual removal to be recorded and authenticated by Engineer I/C and the successful bidder.

04. The successful bidder shall have to deposit 100% of the bid amount in, one installment immediately after issuance of authority letter and prior to start of extraction.
05. The successful bidder shall have to make adequate arrangements for removal of shoal to the extent of advertisement before the water level in the River Jhelum rises and maximum up to 15th March 2015. In case bidder fails to complete the Job upto 15th of March 2015. He shall have no claim over the deposited amount.
06. The successful bidder shall take measures to maintain pollution free environment to the possible extent in and around the area.
07. Construction of Ramp/loading points shall have to be constructed & subsequently removed by the bidder of his own.
08. The agency will have no choice in lifting away material but shall have to excavated & lift whole whatsoever in deposition from top to bed of the River in conformation to approved x-section, partial or superficial extraction shall not be allowed.
09. The removal of deposited material shall have to be strictly in confirmation to embankment profile as directed by Engineer I/C. The ultimate cross section has to be carved out and maintain strictly.
10. Any violation of these conditions or tampering with River profile shall be at the risk and responsibility of the successful bidder and shall entail cancellation of contract and imposition of penalty upto 10% of the bid amount or cost of restoration of damages caused whichever is higher.
11. The bidders are advised to inspect the site before casting their bids.
