

**TERMS AND CONDITIONS:-**

01. Tenders documents shall be available for sale in Divisional Office w.e.f 17-3-017 to 27-3-017 against cash Payment (cost of tender document) as shown against each work on the production of the following self attested documents.
  - a). Certificate of registration with J&K Govt. Sales Tax Deptt. quoting TIN NO. therein.
  - b). State Sales Tax clearance certificate of the latest quarter.
  - c). Experience certificate having executed identical nature of work.
02. The Tenders shall be received in the office of the undersigned on 31-3-017 upto 1400 Hours.
03. Tenders should be supported with a CDR/FDR only from any Nationalized Bank Pledged in favour of Ex. Engineer MID Anantnag, HQ Awantipora Without which tender shall be rejected.
04. In case the date for receipt of tenders happens to be a holiday, the tenders in that case shall be received on next working day.
05. The Tenderer's workshop facilities are subjected to check by the Department with respect to infrastructure available for execution of the job before placement of order.

07. Tenders shall be opened on the same day or any other subsequent date convenient to the opening authority in presence of intending tenderers/authorized representatives, who may wish to be present at the time of opening.
08. The tenders shall remain valid for a minimum period of 180 days from the date of opening of the tenders.
09. The opening authority reserves the right to reject any or all tenders without assigning any reason thereof.
10. The job should be completed within 30 days from the date of Allotment order.
11. Penalty: In the events of the contractors failing, declining, neglecting or delaying the supply, installation and testing of equipment or in the event of any damage occurring or being caused by the contractor or in the event of any default or failure by the contractor in complying with any of the terms and conditions of the contract, the government shall, prejudice to any other remedy available to it under any law for the time being in force in the state:
  - Terminate the contract after Thirty (30) days notice and/or
  - Recover the amount of loss caused by damages failure or default as may be determined by the government and/or
  - Impose a penalty for delay in supply, installation and testing of the equipment upto a maximum of 10% of the value of contract.
  - Forfeiture of security deposit
