TERMS & CONDITIONS

1. The contractor is bound to start the work within 07 days from the date of issuance of allotment/Letter of Intent and is bound to complete the same within stipulated period of time as mentioned against each job. If the lowest tenderer fails to start the work well in time, no further notice shall be served. His CDR shall be forfeited immediately and action as warranted under rules shall be recommended to the higher authorities.
2. The work is to be done under the close supervision of Assistant Executive Engineer concerned.
3. Successful tenderer shall have to draw an agreement with the department within 07 days from the date of placement of order. However, non-drawl of agreement will not prevent the firm/contractor from the contractual obligations related to this contract.
4. Executive Engineer Mechanical Irrigation Division Baramulla reserves the right to accept or reject any or all tenders without assigning any reason thereof.
5. All the intending tenderers are requested to inspect the site of work before quoting their rates for the subject work.
6. No tools and tackles shall be provided by the department and are to be arranged by the successful tenderer on his own.
7. The successful tenderer has to maintain on his own watch and ward during the execution of work at site.
8. Rates shall be quoted in accordance with Technical Specifications and keeping in view the terms and conditions of the notice and shall be duly tapped with transparent tape.
9. In case of any defect/damage occurring to the above equipment(s) during working period of 06 months after the work is executed, the same is to be rectified within 10 days from serving of notice to the contractor by the department.
10. Tenders Documents shall be issued to only those registered firms who produce GST Registration Certificate & Tax Clearance Certificate. However, the SSI Unit Holders shall be have to pay the costs as per standing Government Instructions.
11. GST as applicable in J&K State shall be deducted from the contractor's claim.
12. **Payment Clause [Subject to Availability of Funds]:**
 - a) 80 % shall be released on execution of work at site subjected to availability of funds.
 - b) 10 % shall be made after successful testing and commissioning of the work at site
 - c) And balance after the completion of Defect Liability Period [DLP].
