- The Bids shall be deposited on the website <http://jktenders.gov.in> from the date of bid submission date (0900Hrs) to bid closing date (1400 Hrs).
- The original copy of tender fees must be delivered at the office of the *Executive Engineer Mechanical Irrigation Division, Shadipora* along with original copy of EMD, DD, through registered / speed post /by hand prior to one day of opening of the tender. The Department will not be responsible for any delay in delivery of the documents.
- The complete bidding process will be online <http://jktenders.gov.in>.
- The Technical bids received shall be opened online in the office of *Executive Engineer Mechanical Irrigation Division, Shadipora*.
- The Financial bids of the bidders shall be opened online in the office of the *Executive Engineer Mechanical Irrigation Division, Shadipora* date of which shall be communicated separately.
- Bids must be accompanied by bid security and cost of Tender Document as specified in column 3&4 of the NIT table, payable at Srinagar pledged in favour of *Executive Engineer Mechanical Irrigation Division, Shadipora*. Bid security will have to be in form of CDR/FDR or an irrevocable BG of any scheduled bank and shall have to be valid for one year or more after last date of receipt of Bid. The cost of downloaded tender documents should be in form of DD in favour of Superintendent Engineer Mechanical Circle Irrigation and Flood Control Department Srinagar, payable at Srinagar.
- Only original pump manufacturers or their Authorized dealers or Registered firms/contractors having relevant and sufficient experience in the field of subject work can participate in the tendering process.
- The bid for the said work shall remain open for acceptance for a period of 180 days from the date of opening of bids. If any bidder/tenderer withdraws his bid/tender before the stated period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.

- Instruction to bidders regarding e-tendering process**
 - The interested bidder can download the NIT/bidding document from the website <http://jktenders.gov.in> To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for

digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendor. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.

- a. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
- b. Bids will be opened online as per time schedule.
- c. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
- d. The department will not be responsible for delay in online submission of bids whatsoever reasons may be
- e. All the required information for bid must be filled and submitted online
- f. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents The original instruments in respect of cost of documents, EMD and relevant documents be submitted to the Tender Inviting Authority by Speed/Registered post/courier as per time schedule specified.
- g. The details of cost of documents, EMD specified in the tender documents should be the same, as submitted online (scanned copies) otherwise bid will not be accepted.
- h. Bidders can contact the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.
- i. Bidders are advised to use “**My Documents**” area in their user on jktenders.gov.in, e-tendering portal to store important documents like Experience certificate, Balance sheet, VAT Certificate, sales Tax Clearance Certificate and other related documents etc., and attach these certificates as Non Statutory documents while submitting their bids.
- j. Bidders are advised not to make any change in BOQ (Bill of Quantities) contents or its name. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the net item rate inclusive of all taxes and it should be saved with the same as it contains.
- k. **Bidders are advised to scan their documents at 100 DPI (Dots per Inch) resolutions with Black and White, JPEG Scan properly, convert scanned images to PDF**
