



Terms and conditions

1. The rates shown against each item/work above allotment order are firm and final.
2. The rates are inclusive of all taxes, duties, levies, handling and transportation/care respective Lift Irrigation/Dewatering Station.
3. Material/Spares used shall be of standard make and quality. Any sub-standard, defective material/spares shall be straight way rejected and no claim, whatsoever, shall be entertained.
4. The work shall be completed within the period of 2-3 days positively, failing which a penalty up to allotment shall be imposed on the firm at the discretion of Executive Engineer, Mechanical Irrigation Shadipora.
5. In the event of the failure the firm to execute the ordered works within the stipulated time, faulty/defective execution of the work, the Executive Engineer Mechanical Irrigation Division Shadipora reserves the right to get the works executed through some other agency, partly or in full, at the risk and cost of the firm.
6. The work executed shall be guaranteed for satisfactory performance for one complete irrigation season. During this warranty period, the firm shall be liable to replace any item/spare, and/or, re-execute the work without any extra cost to the department, in case the performance of the same is not satisfactory.
7. The firm shall execute an agreement with the department immediately after issue of the allotment order without which the firm shall not be entitled to any payment even if the works are executed in full.
8. The payment shall be made to the firm as and when the funds are available in the division and department shall not be responsible on this account which may please be noted.
9. Old scrape if involved shall be returned to the divisional store against proper return indent.
10. 100% Payment shall be made to the firm after successful completion of the jobs at site as per specifications of the allotment order 10% of the billed amount shall be kept in deposited and shall be released after the defect liability period as per the clause VI above.
11. Performance Security which the firm has kept as the deposit in divisional office shall be released only after the AMC 2024-25 contract is over.
12. All the terms and conditions as laid down in PWD form 25 double over leaf/e-Nit under reference shall remain in force.
