The Drawing and Disbursing Officer shall get the certificates/other documents of the candidate verified from the issuing authorities. If, on verification, the certificate(s)/document(s) produced by the appointee prove to be fake or forged, the appointment shall deemed to have been cancelled abinitio and legal proceedings shall follow.
- The salary of the appointee shall not be drawn and disbursed to her unless all certificates produced by the applicant are verified and found genuine.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 Dated: 24/12/2009.
