The appointment of the above candidates as Junior Assistants in this department shall further be subject to the conditions that:-

- i. Each appointee shall submit an affidavit in the shape of undertaking at the time of joining that in case any of adverse report about his Character and Antecedents is received from the Office of the IGP, CIDJ&K, to whom a reference shall be made by the concerned Drawing & Disbursing Officer, the candidate shall have no right to claim his/her appointment as Junior Assistant in the department and his/her appointment as such, shall be deemed to have been cancelled ab-initio;
- ii. Verification/genuineness of the qualification certificates and reserved category certificates from the concerned issuing authorities is received.



The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.

The appointee shall be on probation for a period of 02 years and shall undergo and qualify the Secretariat Assistant Examination (Foundation Course) during the period of probation.

The inter-se-seniority of the appointees shall be in order of merit as per the selection list furnished by the J&K Service Selection Board.
