- 1) :-**The Bidders are advised to read all conditions laid down in the eNIT carefully before uploaded soft copy any shortfall if any found in the soft copy the tender shall be rejected**
  - 2) **As per Circular issued by the Government of Jammu and Kashmir Civil Sectt. Finance department vide No.OM No.A/24(2017)-651dtd.07-06-2018 which reads as under :-**
    - a) **Furnishing of Hard Copies of bids immediately after submission of E-tenders is dispensed with. The same should be obtained only from the Bidder who's declared Ist Lowest(L-1) after opening of financial bids.**
    - b) **The Cost of tenders should be collected by uploading a copy of necessary Treasury Challan/Receipt.**
  1. **Bids must be accompanied with cost of Tender document in shape of Treasury Challan/Receipt (Debited to M.H.0215 –Rev. Misc) and Earnest Money in the shape of CDR/FDR in favour of Executive Engineer Hydraulic Division Uri failing which the tender will be rejected outrightly. The issuing date of CDR/FDR uploaded must be between issuing date to Bid Submission end date of eNIT. CDR/FDR(Earnest money/Bid security) and relevant bid document shall be obtained from the lowest bidder before the fixation of contract.**
    2. The date and time of opening of Bids shall be notified on Web site www.jktenders.gov.in and conveyed to the bidders automatically through and e-mail message on their e-mail address. The bids of responsive bidders shall be opened online in the office of Executive Engineer Hydraulic Division Uri
    3. The bids for the work shall remain valid for a period of 90 days from the date of opening of bids.
    4. The normal deposits to be deducted as per GFR2017 rules from running bills to be released after total completion of the work.
    5. The tender opening authority reserves the right to accept or reject any or all tenders or any part of any tender without assigning reason thereof.
    6. **Instruction to bidders regarding e-tendering process.**

**Bidders are advised to download bid submission manual from the“ Downloads” option as well as from“ Bidders Manual Kit” on website www.jktenders.gov.in to acquaint bid submission process.**

**To participate in bidding process, bidders have to get ‘Digital Signature Certificate (DSC)’ as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendor.**

**The bidders have to submit their bids online in electronic format with digital Signature. No financial bid will be accepted in physical form.**

**Bids will be opened online as per time schedule mentioned inPara-1.**
  - 7.5. **Bidders must ensure to upload scanned copy of all necessary documents with the bid.**
- Note:-Scan all the documents on 100dpi with black and white option.**
7. The department will not be responsible for delay in online submission due to any reasons.
  8. **Scanned copy of cost of tender document in shape of Treasury Challan/Receipt (Debited to M.H.0215 -Rev.Misc) in favour of Executive Engineer Hydraulic Division Uri and Earnest Money in the shape of CDR/FDR in favour of Executive Engineer Hydraulic Division Uri failing which the tender will be rejected outrightly.**
  9. Bidders are advised not to make any change in BOQ (Bill of Quantities)

contents. The BOQ downloaded should be inclusive of all taxes.

10. Bidders should note that if the documents uploaded/submitted on the basis of which the contract has been awarded are found fake/not genuine at any time, the contract shall be cancelled and the contractor/ bidder shall be blacklisted for participation in this division for a period of **One year** besides the performance security deposited for the said work shall be forfeited.

11. **Price escalation and Taxes:-** The %age quoted by the bidder shall be deemed to include price escalation and all taxes upto completion of the work. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill as per the rates prevailing at the time of recovery.

12. Bidders are advised to use “My Documents” area in their user on www.jktenders.gov e-Tendering portal to store such documents as are required.

13. **Instruction to Bidder (ITB)**

The Bidder must have to upload (soft copies) of the following documents (Photostat/Original should be clearly seen in all respect with Ink Signed and Seal):-

14. **The department will not be responsible for delay in online submission due to any reasons.**

15. The bidder at his own responsibility and risk should visit and examine the site of the work and its surroundings before submission of bid.

16. **The Departmental material** shall be supplied to the contractor as per the stock rate in vogue for financial year 2024-25 . In case of non availability of stocks in divisional stores the contract or may purchase required material of quality and specifications prescribed, to be certified by Engineer Incharge after getting non availability certificate from Executive Engineer and shall not be entitled for any type of excessive rates on this account

17. If the bidder does not quote rate for any item of the rate list/quantity schedule, cost of such item/items shall be deemed to be part of the overall/ total contract value and no rate shall be allowed for such item/items In the allotment of contract.

18. The work should be executed within the time limit as stipulated in the NIT.

19. In case if the contractor fails to execute the work as per condition and time limit prescribed in the NIT. The work shall be put to fresh tenders at his risk and cost, besides debarring from participation in tendering process. In addition to imposition of penalty as warranted under rules.

20. The Labour Cess/Service Tax will be deducted from the gross amount as per the rates in vogue at the time of payment.

**General Conditions of Contract:-**

21. The date of start of the work shall be reckoned from the starting date of next financial year or from three days after the issuance of LOI/Contract allotment as the case may be.
22. **Penalty for delay in completion:**-In case of delay in completion of work beyond stipulated period of completion, penalty upto maximum of 10% of the contract shall be imposed.
23. **Advance Payments:**-No Mobilization/Equipment Advance shall be paid .
24. **Secured Advance:**-No Secured Advance is admissible/Payable.
25. **Schedule of payment:**-The payment shall be made on the basis of availability of funds and value of work executed, shall be determined by the Engineer I/C.
26. **Amendment of bidding document:**-Before the deadline for submission of bids the employer may modify the bidding documents by issuing Addenda.
27. **Restoration of work:**- On completion of contract the contractor shall be responsible to remove all un-used material and restore all work in its original position at his own cost.
- a. **Arbitration:**-The arbitration shall be conducted in accordance with the arbitration procedure stated in the J&K conciliation and Arbitration Act No:-xxxv of 1997 issued vide SRO No:-403 vide Notification of J&K Govt., " Law Department"11th December-1997.
- b. **Safety:**-The contractor shall be responsible for safety of all activities at site of work.
- c. **Discoveries:**-Anything of historical or other interest or of significant value unexpectedly discovered on the site shall be the property of the Govt.
- d. **Tests:**-The contractor shall be solely responsible for carrying out the mandatory tests required for the quality control at his own cost.
- e. **Termination:**-The employer may terminate the contract if the contractor causes a fundamental breach of the contract.
- f. The date of start of the work shall be reckoned from the starting date of next financial year or from three days after the issuance of LOI/Contract allotment as the case may be. In case the agency fails to execute the work, the deposits in the shape of performance Security shall be liable for forfeiture besides the Contractor will be suspended for participation in the tendering process in this department for a period of one year from the bid due date of this work without serving any notice.
- g. **ALL KEYCONSTRUCTION MATERIAL shall have to be strictly as per prescribed specifications and approval of the Engineer In-charge.**
- h. **Laying of GI / DI Pipes**
- i. The pipe material ISI marked Galvanized Mild Steel tubes should confirm to IS :1239 (pt.1)/2004 6<sup>th</sup> revision read with up-to-date amendments in random length of 4 to 7 mtrs, screwed on both ends as per IS: 554/1990, socketed at one end & other end protected with plastic protector in various sizes of nominal bore & classes. The socket confirming to IS: 1239 (pt. II/1992) (4<sup>th</sup> revision) with amendment No. 1 to 3 & latest on date & ISI marked Centrifugally cast(Spun) D.I Pipes with socket & spigot ends as per IS : 8329/2000 read with latest amendments in standard lengths of 4,5,5.5 & 6 mtrs for classification K7 & K9 ranging nominal diameters as indicated here under suitable for push on joint ( Rubber Gasket-D joining) with cement mortar lining inside the pipes Without side Zinc coating with Bituminous finish coat as per IS 8329/2000 read with amendment NO, 1, hydrostatic tests as per clause -11 of IS :8329 with latest amendments each pipe to be supplied with EPDM Rubber Gasket conforming to IS: 5382 Of 1985. The class of pipe is specified as light "A". All GI/DI pipes should be entrenched especially in hilly areas with a trench depth of 0.60 m to 1.00 m and where same is not technically possible the Pipes so kept naked will have to be insulated with PUF using Chicken mesh & tin foil of approved thickness & specifications against the proposed earthwork and nothing extra shall be paid to the contractor on this account.
- ii. The pipe material shall be supplied from reputed manufacturers. The agency shall initially establish a store at the project site for storing before the same is issued to sites after getting approved. The approval process shall be documented on material approval sheets duly signed by in charge engineer's quality control committee and contractor.
- iii. The contractors shall be authorized to purchase the material viz. cement, steel, crates and pipe material of approved brand and manufacture conforming to relevant BIS/IS Codes as per set codal procedure/ rules and shall be verified /checked through the committee constituted by Quality Control and Procurement Division Srinagar
- i. Satisfactory maintenance for such period.
- j. Failure on part of the contractor to fulfill his obligations of maintenance schedules

shall result in for feature of the Performance Security deposits held for this purpose for this work.

- k. Fundamental breach of contract will include.**
- i. Continuous stoppage of Work for a period of 30days without authorization of Engineer in- charge.
  - ii. Contractor is declared bankrupt.
  - iii. Any evidence of involvement of contractor incorrupt practices.
  - iv. If the contractor indulges in willful disregard of the quality control measures put in place by the department.
  - v. Contractor delays the completion of work beyond stipulated time of completion.
  - vi. Pursuant to the process of termination of defaulted contract, the employer reserves the right to invite fresh tender for the balance work at the risk and cost of defaulter contractor.

- 28. Insurance:-**Insurance cover to Labour/Machinery/Work/Plant material/ Equipment by the contractor shall be mandatory.
- 29. Laws Governing the Contract:-**The contract shall be governed by Laws of the land.
- 30. Courts Jurisdiction:-**In case of any disputes/differences between contractor and Department the jurisdiction shall be J&K State.
- 31. Time Extension**
- a. The work is to be completed within the time limit specified in the NIT and the time of completion will also increase/decrease in proportion with additional/deleted quantum of work depending upon the actual quantum of work.
  - b. Requested for extension of time shall be made by the contractor in writing not later than fifteen days of happening of the event causing delay. The contractor shall also indicate in such a requested the period for which extension is desired.
  - c. Abnormal/bad weather of serious loss of damage by fire of Civil commotion, strike or lockout (other than among the labour engaged) affecting any or the trades employed on the work, or non availability of departmental stores. Any other cause which in the absolute discretion of the accepting authority is beyond the contractor's desire.
  - d. On contractor's representation based on the grounds as detailed above the time for completion of the work may be extended by a period considered reasonable by the Department.
  - e. Extension of time shall be also admissible in the event of temporary suspension of work.
- 32.** The tender/bid is liable to rejection if it does not fulfill the requirements as laid down in NIT.

All other terms and conditions same as laid down in the PWD Form 25 Double shall also remain in force.
