- 4) Bids must be accompanied with cost of tender document (Non- Refundable/ Non- transferrable) to be deposited under MH: 0702-Rev. Misc. in shape of **Treasury Challan / receipt or e-Challan** (mentioning therein e-NIT No and Serial No of Work) to be pledged in favour of the Executive Engineer Irrigation and FC Jal Shakti Division Ganderbal and **earnest money/ bid security in shape of CDR/FDR** pledged to the Executive Engineer Irrigation and Flood Control Division Ganderbal, besides the dates on the instruments must not be prior to date of issuance of this Notice. The bids for the work shall remain valid for a period of 90 days from the date of opening of Price bids.
- 5) The earnest money shall be forfeited if: -
- a) Any bidder withdraws his bid during the period of bid validity or makes any modification in terms and conditions of the bid.
- b) Failure of successful bidder to execute the agreement within 10 days after fixation of contract.
- c) The successful bidder fails to submit the requisite performance security and additional performance security within the prescribed time frame.
- 6) Instructions to bidders regarding e-tendering process.

- a) Price escalation and Taxes: The item wise cost / offer be quoted by the bidder entirely in Indian Rupees and the cost quoted shall be deemed to include price escalation and all taxes till completion of work.
- b) Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill of the contractor as per the rates prevailing at that time.
- c) The bidder should upload the latest GST return (latest quarter) & the payments will also be made subject to the production of latest GST returns.
- d) Bidders are advised to use "My Document" area in their uses on JK tenders e-Tendering portal to store such documents as are required.
- e) Complete Bio Data of contractor/agency as per Appendix (I).
- f) Errors/omissions, if any shall be read with SOR 2022.
- g) Nothing shall be paid on account of dewatering, diversion or construction of ring bund quantities executed in or under water, making of tracks, ramps and removal of the same after completion even if involved at site. The contractor shall quote their rates accordingly.
- i) Drawl of Agreement within 10 days after fixation of contract.
- j) Production of original documents necessary for verification on declaration of the lowest bidder by or before 07 days of the opening of Price Bid/generation of comparative statement.

13) <u>Material: -</u>

- a) In case of non-availability of stocks in divisional stores the contractor may purchase the required material of quality and specifications prescribed, to be certified by the Assistant Executive Engineer in charge after getting non availability certificate from Executive Engineer and shall not be entitled for any type of excessive rates on this account.
- 14) Qualification criteria for the work and other terms and conditions are as below:
 - a) All bidders shall include the following information and documents with their bids G.S.T./ latest GST Return (Latest quarter)/ PAN No/Regd. Card duly renewed for the current year.
 - b) If the bidder does not quote rate for any item of the BOQ, such item/items shall be deemed to be part of the overall/ total contract value and no rate shall be allowed for such item/ items.
 - c) The date of start of the work shall be reckoned with in 7th day from the date of issuance of LOI/ contract allotment as the case may be.
 - d) **Restoration of work: -** On completion of contract the contractor shall be responsible to remove all un-used material and restore all work in its original position at his own cost, any damage if caused during execution of work shall be restored by the contractor at his own cost.
 - e) The contractor has to manage housing for labours, electricity, water storage for material, watch and ward and other facilities at his own.
 - f) In case of any disputes/differences, the jurisdiction shall be to the courts situated in Srinagar only. In case of any dispute regarding the work, the concerned Chief Engineer shall be the sole Arbitrator.
 - g) **Defect Liability Period (DLP):** The contractor should be responsible to maintain the work within a defective liability period of Six (06) months. The Defective Liability Period (DLP) shall be 06 (Six) months after the completion and successful commissioning of the work and the date of completion of the works shall be taken financially as recorded by the concerned Assistant Executive Engineer in the works register maintained by him for the

- said works. 10% of the payment retained as deposit money shall be released after completion of this Defective Liability Period.
- h) **Safety:** The contractor shall be responsible for safety of all activities at site of work during execution.
- i) Termination: The employer may terminate the contract if the contractor causes any fundamental breach of the contract, which shall include stoppage of work without any reason.
- 15) The successful Contractor has to start the work simultaneously at different location as and when directed by the Engineer in-charge.
- 16) For flood mitigation purposes the contractor will provide the machines within 30 minutes in the respective jurisdiction at the required spots to meet up any eventuality/exigency.
- 17) As a flood preparedness, the agency has to dump good earth for filling up EC bags at the sites identified by the engineer in-charge immediately after award of contract and the necessary permission from Geology and Mining department and other concerned departments shall be the responsibility of contractor and the rates quoted for the item shall be inclusive of all royalty etc charged by the concerned departments as per the rates in vogue.
- 18) Any damages that will occur to the work during the course of execution due to flash floods or any other natural calamity, the work will have to be rectified/ repaired by the executing agency out of his own expenses and nothing extra will be paid on the account by the department
- 19) The successful bidder (L1) has to submit performance security @ 10% of contract value that will be released after 01 year from the date of completion of all contractual obligations including Defective Liability Period and has to deposit an additional performance security within 03 days from the date of issuance of intimation as per the below mentioned scale:

- 20) The rates quoted for the unit rate contracts shall be allotted ratio proportionately with respect to the quoted tender depreciation.

Department. Such extra item shall be paid at J&K SOR 2022 rates with allotted appreciation/ depreciation. In case such item does not figure in J&K SOR 2022, the same shall be paid as per the current market rate analysis to be approved by the competent authority. No extra claim towards any type of tax, freight, etc shall be entertained whatsoever. It must be noted that during the currency of the contract and its extended period if any, no price escalation whatsoever shall be allowed in respect of any of the items of the work.

- The contract shall be purely in case of exigencies before or during the Yatra and as such there could be instances where no item of the contract would be required and the executing agency/ contractor shall have no right to claim for non execution/ operation of the contract.
- 25) The contract shall not be utilized for the spots already identified and tendered vide this office eNIT No 01 of 2024-25.

- 29) <u>Time Extension: -</u>
 - a. The work to be completed within the limit specified in the NIT and the time of completion will also increase/ decrease in proposition with additional/ deleted quantum of work depending upon the actual quantum of work.
 - b. Request for extension of time shall be made by the contractor in writing not later than fifteen days of happening of the event causing delay. The contractor shall also indicate in such a request the period for which extension is desired.
 - c. Abnormal/bad weather or serious loss of damage by fire or civil commotion, strike or lockout (other than among the labour engaged by the contractor) affecting any or the trades employed on the work or Non availability of departmental stores. Any other cause which in the absolute discretion of the accepting authority is beyond the contractor's desire.
 - d. On contractor's representation based on the grounds as details above the time for completion of the work may be extended by a period considered reasonable by the department.
- 30) Fundamental breach of contract will include:
 - a) Continuous stopping of work for a period of 30 days without authorization of Engineer in-charge.
 - b) Contractor being declared bankrupt.
 - c) Any evidence of involvement of contractor in corrupt practices.
 - c) Contractor delaying the completion of work beyond stipulated time of completion.
