TERMS AND CONDITIONS: -

- Every Bidder is expected to have the Knowledge of roads and acquaint himself with the road conditions, approaches within the jurisdiction of Irrigation and Flood Control Department Srinagar and shall be deemed to have examined the tender document, detailed specifications, data etc before quoting his rates. No claim whatsoever should be entertained later on the plea of what so ever, which was or was not foreseen by the bidder.
- Bidders should quote their rates legibly in the prescribed column/space against item of rate list. The rate so quoted should be for the complete item in the unit, inclusive of all taxes, duties, and levies, rebates etc.
- The bidder shall responsible for the watch and ward of the vehicle. The damages caused if any during the contract period have to be set right by the Owner of the Vehicle.
- The department will not be responsible for any damages/destruction caused to the vehicle or driver by floods, torrents, fire/civil commotion, terrorist act, lightening, earth quake, cloud burst or any other natural calamity. The

- contractor on his own expenses will arrange for the safety provision outlined in the relevant sections of the relevant Act to comply with the statutory regulations, ISI recommendations and codes.
5. Executive Engineer Irri. And Flood control division Srinagar reserves the right to postpone the tender submission/opening date/reject any tender without assigning any reason thereof.
 6. No tools and tackles for the vehicle would be made available by the department. The Successful Bidder shall make his own arrangement for all these facilities.
 7. For any dispute the decision of the Chief Engineer Kmr I & F.C. Department Srinagar is final.
 8. The bids found to be abnormally low shall be liable for rejection.
 9. The Driver should have the experience of running the vehicle on hiring basis for at least 2 (Two) years.
 - 10. The successful bidder should provide dedicated Vehicle and driver and any change in vehicle and /or driver should be made only in very exceptional circumstances. The contractor has to submit all the necessary documents of the vehicle such as Registration certificate, pollution certificate, Insurance's certificate or any other document as required by the motor vehicle Department/concerned authorities. The driver should be having transport license, for driving commercial/passenger vehicle with minimum 2 years' experience and the antecedents should be duly verified by concerned authorities, at the instance of contract.**
 11. The vehicle shall be deemed to be at the disposal of Executive Engineer Irrigation and Flood Control Department Srinagar during the period and the rate quoted should be for full day inclusive of the driver as well as for Technical Officer With Chief Engineer Kashmir I&FC Department.
 - 12. The liability driver and all expenses relating to maintenance, insurances, parking, toll, change of lubricants etc would solely and wholly be the responsible of the successful bidder and the department will not bear any liability apart from hiring charges.**
 13. The fuel will be provided by the department, if available as per the mileage (Fuel consumption) fixed by the Motor Vehicle Department after verification of the actual measurement of the trips by concerned Engineer or otherwise, if the fuel is not available with the department the payment on account of fuel charges will be paid as per prevailing rates. In case the mileage of the vehicle is not specified by the motor vehicle department, the mileage will be fixed by the negotiation committee.
 14. The successful bidder should fulfil all the conditions prescribed in the section 66 of Motor Vehicle ACT 1988 for hiring of vehicle.
 15. Driver should be well versed with the roads and places within the jurisdiction of Irri. And Flood control Department.
 16. Driver should be decent and well behaved and should not have any criminal case against him and should not have any history of accidents.
 17. Vehicle should be clean and odorless.
 18. In case of breakdown of vehicle, a substitute vehicle shall be provided by the contractor immediately. In case vehicle does not report with reasonable time or does not report at all, the Department will have the right to hire a vehicle from Market and additional cost incurred by the Department will be borne by the successful bidder. In case neither substitute vehicle is provided nor a vehicle is hired by the department, proportionate charges are liable to be deducted from the contract charges payable.
