3. The earnest money shall be forfeited if:

Any bidder / tenderer withdraws his bid/ tender during the period of bid validity or makes any modifications in the terms and conditions of the bid.

Failure to produce the original documents necessary for verification on declaration of the lowest bidders on which bidder was qualified by or before 07 days of the opening of Price Bid / generation of comparative statement

Failure of Successful bidder to execute the agreement within 15 days after fixation of contract

4. Instructions to bidders regarding e-tendering process.

Bidders are advised to download bid submission manual form the “Downloads” option as well as from “Bidders Manual Kit” on website www.jktenders.gov.in acquaints bid submission process.

To participate in bidding process, bidders have to get ‘Digital Signature Certificate (DSC)’ as per information Technology Act- 2000. Bidders can get digital certificate from any approved Vendor.

The bidder has to submit their bids online in electronic format with digital signature. No bid will be accepted in physical form.

Bids will be opened online as per time schedule mentioned in above at S. No. 1.

Bidders must ensure to uploads scanned copy of all necessary Documents.

5. Note: Scan all the documents on 100 dpi with black and white option.

The department will not be responsible for delay in online submission of tender due to any reason/ reasons.

Scanned copy of Bid Security Declaration Form as per attached format, cost of tender documents in shape of or Treasury challan/ receipt pledged to the Executive Engineer MID Shadipora . DIC Registration,, G. S. Tin No with latest GST Return (latest quarter).and Pan Card. (the date of treasury challan shall be between the date of publish tender upto bid submission last date)

Bidders are advised not to make any change in BOQ (Bill of quantities) contents, in no case they should attempt to create similar manually. The BOQ downloaded should be used for filling the item rate inclusive of all taxes and it should be saved with the same name as it contains.

The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rates quoted shall be deemed to include price escalation and all taxes up to completion of the work unless otherwise, specified.

6. Only firm/Agency shall have full-fledged workshop/experience and with all the equipment’s requisite for the repairing of the items, and registered Government departments/ reputed private organizations, PSUs, etc. can participate in the tendering process. It is pertinent to mention here that for ready proof the tenderer should upload the PDD agreement copy of the workshop. Copy of relevant proof shall be uploaded

7. The bid shall remain open for acceptance for a period of 90 days from the date of opening of bids. If any bidder/tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
